Government in G.O.Rt.No.421, HE (IE.I) Department, dt.04.06.2001, have permitted for preservation of proportionate leave to Junior Lecturers who were prevented from availing summer vacation due to their involvement in conduct of examination, census duty or election duty and for reduction in summer vacation period due to increase of working days from 180 to 220. The said provision has been extended to the Aided and Redeployed Teaching & Non-teaching employees by the government in the G.O.Ms.No.23 H.E.(IE.II) Dept., dt.09.03.2011.

Further the Secretary, Board of Intermediate Education in his letter, dt.19.07.2012, has stated that I.P.E. Advanced Supplementary. Examinations May / June 2012 were conducted from 16.05.2012 to 25.05.2012 and as per the schedule, the personnel who were allotted examination work, were directed to take up duties three (03) days before the schedule i.e. from 13.05.2012.

In view of the above Correspondents of Aided Junior Colleges and Principals of Government Junior Colleges (where redeployed staff are working) are permitted to preserve **09 Days** of Earned Leave to the Teaching and Non-Teaching staff working in Aided Junior Colleges and Redeployed staff working in Government Junior Colleges in the State due to enhancement of working days from 180 days to 220 days in the year 2011-12. Also they are permitted to preserve **(04) Four Days** of Earned Leave to the Aided /Redeployed staff who were involved in conduct of I.P.E. Advanced Supplementary Examinations May / June 2012 duly obtaining necessary attendance certificates from the concerned authorities.

They are directed to make necessary entries in the Service registers of the incumbents to this effect. The receipt of these proceedings should be acknowledged.
