ORDER:

In the reference 1st read above, orders have been issued fixing schedule of dates for presentation of bills in Treasuries on par with Pay and Accounts Officer, Hyderabad with effect from 1-11-1992. In the reference 2nd read above, instructions have been issued fixing the dates for issuing of cheques.

In the reference 3rd read above, orders have been issued to admit the Honorarium bills of Anganwadi Workers, Helpers, Home Guards and payments under Other Contractual Services into audit on par with salary bills duly following the budgetary procedures.

In the reference 4th read above, the Higher Education Department has stated that the salaries are paid to the aided degree college lectures by the State Government under the Grants-in-aid. A number of highly cumbersome procedures are followed by the Government prior to, and after the release of the grants to meet the salary bills of the private aided college teachers. The staff members working in the Private Aided Colleges in the State are not receiving salaries on 1st day of every month causing inconvenience to them. The department has therefore requested the Government for payment of salaries on 1st of every month to the staff members working in the aided institutions under Collegiate Education/Technical Education/Intermediate Education and School Education.

Government after careful consideration of the matter hereby order that the following be added as item 6 of Para 2 of G.O. 1st read above.

AMENDMENT

6. Payment of salaries on 1st of every month to the staff members working in the aided institutions under Collegiate Education/Technical Education/Intermediate Education and School Education. :On par with regular Government employees.
